- 2. Assam State Rural Livelihoods Mission (ASRLM) will coordinate and monitor the project. The Project Cost of Rs. 4,26,83,928.00 (Rupees Four Crore Twenty Six Lakh Eighty Three Thousand Nine Hundred Twenty Eight only) shall be released to the Project Implementing Agency in five installments in the ratio of 25:25:25:15:10 subject to provisions of DDU-GKY Guidelines and Standard Operating Procedures (SOP).
- 3. The applicant PIA must open separate savings bank account in Scheduled Commercial Bank and the account no. should also be share with ASRLM. All project funds must be transacted through this account. The account must be mapped with PFMS.
- 4. The 1<sup>st</sup> installment amounting to Rs.1,06,70,982.00 (Rupees One Crore Six Lakh Seventy Thousand Nine Hundred Eighty Two) will be released to the PIA upon signing of the Memorandum of Understanding (MoU) and submission of Bank Guarantee.
- 5. Bank guarantee shall be obtained from any Scheduled Commercial Bank for the duration of the project. The applicant PIA needs to submit Bank Guarantee @10% of the released amount amounting to Rs.10,67,098.00 (Rupees Ten Lakh Sixty Seven Thousand Ninety Eight only) against the 1<sup>st</sup> installment.
- 6. In the event of release of further installments, the preceding Bank Guarantee will be released by ASRLM and the PIA needs to submit fresh Bank Guarantee @10% of the amount to be released in subsequent installments.
- 7. The funds disbursed for the skill development project under DDU-GKY subject to audit by Chartered Accountant. The fund disbursement for the skill development project under DDU-GKY shall also be audited by the Comptroller and Auditor General of India, if Central/State Govt. desires.
