You will have to further register each BSDC for KYP on the web portal of BSDM (www.skillmissionbihar.org) by following due online registration processes as per stipulated terms & conditions. You have to initiate registration processes of each BSDC within 10 days of issuance of this LOA and have to complete the registration process within 45 days from the date of issuance of this LOA.

Kindly note that your organisation would be mandatorily required to equip the allotted BSDC with a minimum of 20 Laptops / Computer Systems and one server in each of the two rooms provided for setting up of computer lab. The systems have to be as per the specifications provided in the KYP section of the web portal of BSDM (www.skillmissionbihar.org).
