- 2. The FPO formation and promotion activities will be undertaken as per "Operational Guidelines for formation and promotion of 10,000 FPOs issued by Ministry of Agriculture & Farmers Welfare" during 2020.
- 3. The Formation and Incubation cost of CBBO is limited to maximum of Rs. 25 lakh (Rs. Twenty Five Lakh Only) per FPO of support or actual which is lesser, is to be provided for five years from the year of formation. The cost is inclusive of applicable taxes for a period of 5 years. For the avoidance of doubt, it is expressly clarified that funding to the CBBOs is strictly for mobilization of FPOs and no further support for meeting recurring liability of any kind will be provided beyond the period specified for the project.
- 4. The detailed project deliverables, payment terms and other conditions of the assignment will be as per the Memorandum of Agreement (MoA) to be signed by both the parties. The copy of MoA and the work area will be informed, separately.
