Dear Sir,

I am directed to state that the Executive Committee of the Council of Architecture (COA) at its 203<sup>rd</sup> Meeting held on May 25 & 26, 2019, considered the Review application submitted by your institution at the personal hearing granted to your institution, regarding issuance of show cause to your institution for reduction in intake in the 5 year full-time Bachelor of Architecture (B.Arch.) degree course for the academic session 2019-2020.

Accordingly, the Executive Committee of the Council, after hearing the representatives of your institution and considering your review application together with the information furnished, has decided to fix the intake of your institution in the 5-year B.Arch. degree course as under:

DETAILS OF THE COURSE	INTAKE	PERIOD OF APPROVAL
5-year Full-Time Bachelor of Architecture	80	2019-2020

The approval accorded by the Council to your institution is subject to compliance of the Council Norms attached herewith as **Annexure-A**. The approval accorded to your institution shall be subject to appointment of adequate Faculty of Architecture at your institution as per Council Norms, prior to commencement of academic session 2019-2020. The institution shall be required to appoint faculty to fill up any vacancy, as may be required, within 15 days in case of any faculty leaving the institution.

The final observations of the Executive Committee are as under for your necessary information/compliance:

- Adequate and cadre-wise faculty as per COA Norms must be appointed by the institution.
- The deficiencies pointed by the Council and/or inspectors must be complied with by the institution within one month and compliance be submitted to the Council.



The institution shall initiate necessary remedial actions, if any, based on the observations of the Executive Committee and send its compliance/observations on the same for further consideration. The Council shall be at liberty to inspect the Institution at any point of time to verify the compliance made by the institution and to ascertain that the institution is imparting architectural course as per the Norms prescribed by the Council, from time to time.
